E.B.Gadkari Homoeopathic Medical College Badyachiwadi, Tal-Gadhinglaj, Maharashtra, Kolhapur has been functional since 2002 has submitted an application for permission for sanction of 50 seats in BHMS course for the academic year 2023-24. The College has submitted the Part I information in which the entire functional profile has been narrated. Medical Assessment and Rating Board for Homoeopathy (MARBH) has examined the profile of the College as to whether the college fulfils the essential standards to be fulfilled as per the prevailing regulations under NCH Act, 2020. MARBH examined the application and based on the deficiencies observed on functional aspects, the College was denied Permission for 2023-24 vide letter no. 4-7/2023-24/NCH(MARBH)*115-18)/2519 dated 06/09/2023. College has submitted an appeal with detailed information after rectifying the shortfalls informed in the denial letter on 12/09/2023. And it was further examined by the commission and considered rectification of shortfalls.

The commission after examining the details of the College, proposed that MARBH may issue permission to the college for 50 seats for the Academic year 2023-24. Therefore, MARBH has decided to grant permission for Undergraduate (BHMS) course with an intake capacity of 50 seats to **E.B.Gadkari Homoeopathic Medical College Badyachiwadi, Tal-Gadhinglaj, Maharashtra, Kolhapur for the academic year 2023-24 in the light of the observations made by the National Commission for Homoeopathy.**

It is further informed that a minimum of 15% of undergraduate seats of the permitted intake capacity of 50 UG seats shall be treated as an All-India Quota. The counselling for seats under All India Quota shall be conducted by the respective counselling authority of State UT Govt as designated by Central Government / NCH for the A.Y. 2023-24 and counselling for the remaining 85% of seats or, shall be conducted by the concerned counselling authority of that State/LT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government / NCH for All India Quota or the students admitted thereunder.

All admissions shall be made from NEET-qualified candidates only. If the college disregards the Central Government's stated directive about the All-India Quota or the student enrolled under it, the college's permission is revoked. After the admissions procedure is complete, the MARBH may be informed of the category-wise list of the chosen candidates.


In view of above, you are requested to comply with the above mentioned deficiencies within the stipulated time without fail and submit compliance report. Compliance report will be verified by the University.

The college is not authorized to admit the students for 1st year of the course until receipt of permission of the National Commission for Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi.
- 2) The admission shall be done only through the Competent Authorities.




