Disha Shikshan- V- Vikas Kendra's E.B. Gadkari Homoeopathic Medical College, Maharashtra is functional since 2002 has applied for permission for sanction of BHMS course with 50 seats for the academic year 2024-25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020 and issued a denial letter to the college via File no F. No.4-7/2024-25/NCH (MARBH)/(115-18)/2072 dated 04.07.2024

College made first appeal against F. No.4-7/2024-25/NCH (MARBH)/(115-18)/2072 dated 04.07.2024 regarding denial of 50 UG seats for AY 2024-25 and decision of MARBH was reiterated. College then made a second appeal to the Ministry on 12.09.2024. The Ministry then directed through letter dated 11.11.2024 for Report of weather from Collector Office and for re inspection. The information was taken by District Collector on 29.11.2024 and Re inspection was done on 07.12.2024 observations of MARBH, under NCH are enclosed in the annexures.

Considering the above observations and shortfalls, MARBH has decided to give Conditional permission Disha Shikshan- V- Vikas Kendra's E.B. Gadkari Homoeopathic Medical College, Plot no P-19, Badyachiwadi Midc Area, Adjacent near Shendri Lake, At Post Badyachiwadi, Tal Gadhinglaj, Maharashtra, Kolhapur- 416502 to continue admissions for BHMS course with intake capacity of 40 seats (reduced from 50 seats) for the academic year 2024-2025.

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

All admissions shall be made for NEET qualified candidates only. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be conducted by the concerned counseling authority of the state/UT The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college will be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.

If the college is aggrieved by any decision of the Autonomous Board, may prefer an appeal to the Commission against such decision within 30 days of the communication of such decision as per National Commission for Homoeopathy (Assessment and Rating of Medical Institutions) regulations 2024, section 14 subsection(2)' and NCH General Regulation 2023 section 22'. Manner / instructions for the appeal are attached.
